

## **Email Address Collection Contest - Official Rules**

1. This contest is open to members of U\$X Federal Credit Union who are 18 years or older, legal residents of the United States at time of entry and a member in good standing. Employees of U\$X Federal Credit Union and their immediate family members are not eligible.
2. Eligible members of U\$X Federal Credit Union may enter the contest by:
  - a) Entering their email address via the U\$X FCU website [www.usxfcu.org](http://www.usxfcu.org) and clicking the "Email Contest" banner.
3. All entries received from January 1, to March 31, 2012, will qualify and be entered into the drawing. All entries become the property of the credit union, will not be returned, and are subject to verification. Limit one entry per member account.
4. The winner will be selected by a random drawing to be held on or about the last business day of January, February and March 2012 from qualified entries received. The drawing will be held at U\$X Federal Credit Union at 1293 Freedom Road, Cranberry Twp, PA 16066 by a credit union staff member. The winner will be notified by email. The number of qualified entries will determine the odds of winning.
